1. Divisions and fields in the Graduate School

The Economics Division consists of the Economic Theory Field, Economic Policy I Field, Economic Policy II Field, and Institutional Economic and Economic History Field. The Economic Theory Field focuses on theoretical and empirical analysis of economics, the Economic Policy I Field focuses on the analysis of fiscal and monetary theory and policy, the Economic Policy II Field focuses on international economics and industrial economics, and the Institutional Economic and Economic History Field focuses on economic regimes and economic history.

2. Your choice of supervisor

You should choose a supervisor based on your research field and agenda. In particular, you should be aware of any needs that you are likely to have when writing your thesis. Table 1 shows our courses and the faculty who teach them; you should look over this table when you choose your supervisor. Note that some faculty members may change without an advance announcement.

Use the designated form to present your research proposal. You can attach a typed sheet of paper to the form. It should be 400 to 500 words in length.
